

LAMINATE WARRANTY 25 YEAR LIMITED RESIDENTIAL LAMINATE FLOORING FINISH WARRANTY

Beaulieu warrants to the original purchaser of its laminated flooring product that the surface will not wear through, stain or fade from sunlight or artificial light for a period of twenty-five (25) years. Wear through is defined as a total loss of pattern for a minimum of 2 square inches (13 cm²); loss of gloss is not considered wear through. The warranty period runs from the date of purchase and covers only product used under normal residential conditions. This warranty is for single family owner occupied residential installations only.

This general warranty or parts thereof are subject to restrictions and limitations, excluding those generally accepted by the industry to not apply to laminate flooring.

LIMITED COMMERCIAL LAMINATE FLOORING FINISH WARRANTY

Beaulieu warrants to the original purchaser of its laminate flooring product that the surface finish will not wear through, or fade from sunlight or artificial light for a period of seven (7) years under conditions of moderate commercial traffic and for a period of three (3) years under conditions of general commercial traffic from the date of purchase subject to restrictions and limitations set out below.

Areas that are considered as having moderate traffic include private offices, hotel guest rooms, meeting rooms, multi-housing common areas and hallways.

General traffic areas include hotel or school corridors and lobbies, auditoriums, classrooms, general offices, boutiques, restaurants, retail sales floors.

Other than the designation of the limited commercial warranty period, this general warranty is still subject to restrictions and limitations, excluding those generally accepted by the industry to not apply to laminate flooring.



25 YEAR LIMITED MANUFACTURING WARRANTY

Beaulieu warrants to the original purchaser of its laminate flooring product that, if properly installed and maintained the product shall remain free of manufacturing defects in milling, dimension, lamination or assembly for a period of twenty-five (25) years.

NOTE: Industry standards allow a tolerance in quality variation not exceeding 5% of the total quantity purchased. Beaulieu will replace any defective material from the date of the original purchase. The owner is responsible for final inspection of the product before installation. If the owner hires a third party to install the product the owner is responsible of that party's judgment. Material installed with obvious defects will be deemed acceptable by the owner or installer and will not be considered for warranty. This warranty is subject to restrictions and limitation.

General Limitations, terms and conditions

Beaulieu laminate flooring carries the specific warranties listed above. The following terms and conditions apply to these warranties. If you have any questions regarding the warranty information, please contact Technical Services @ 800-944-2840 or tek.services@beaulieugroup.com.

- 1. Installation. Failure to follow the provided installation instructions may void the warranty. These instructions are located inside each box or can be obtained by contacting Technical Services @ 800-944-2840 or tek.services@beaulieugroup.com or by visiting our website at www.beaulieuflooring.com. Damage resulting from improper storage, handling or installation is not covered by this warranty as well as damage resulting from poor or defective workmanship. Beaulieu laminate must never be installed outdoors nor in bathrooms.
- 2. Visible defects. Before and during installation, all planks must be inspected under sufficient lighting to detect any visible material defects. Under no circumstance should defective planks be installed. Beaulieu will not be held liable for labor costs related to the removal of these defective planks. Any defective planks must be put aside and the retailer must be informed in writing within thirty (30) days, after which no further claim may be submitted. Beaulieu reserves the right to refuse a claim if the amount of defective planks is less than 5 % of total install. Color and gloss variations resulting from adding material to an existing installation are not covered by this warranty.
- 3. Abnormal use. This warranty does not cover floors that have been put through abnormal use or conditions or abused in any way. This includes, but is not limited to, damage caused by standing liquid or water leaks, damage from falling objects, damage caused by dragging objects or furniture, neglect, pets, high heel shoes, pebbles or abrasive materials, and improper maintenance. To prevent such damage, wipe up any spilled liquid immediately, keep your pet's nails trimmed, install protective pads on the feet of the furniture and use a suitable mat at all entryways.



- **4. Accidents and natural disasters.** This warranty does not cover any accidental damage to the product or any natural disasters that may damage the floor. This includes, but is not limited to, damage from fire and smoke, floods, earthquakes, storms, broken pipes or any other plumbing related failures.
- **5. Climate.** This warranty does not cover damage to the product resulting from exposure to extreme heat or cold nor from extremely humid or dry conditions. Exposure to such conditions will void this warranty. Temperature levels must be maintained between 60 and 85°F (15 and 29°C) at all times while relative humidity levels must be kept between 35 and 65% at all times.
- 6. Subfloor and underlayment. Problems resulting from improper subfloors or underlayment may void this warranty. Damages and/or noise (squeaking) resulting from excessive subfloor deflection, improper joist assembly, irregular subfloor or subfloors with voids will not be covered by this warranty. This warranty will not cover damage from water or moisture trapped underneath the floor. Humidity tests on wooden and concrete subfloors must be undertaken before installing the product. The maximum allowable humidity level for a wooden subfloor is 14% using a proper moisture meter. The maximum allowable moisture emission for concrete is 5 lb/24h/1000 sq. ft. using the calcium chloride test and any installation over concrete must include an underlayment that contains a vapor barrier with a minimum of 6-8 mils (0.15-0.20 mm) thick polyethylene film.
- 7. Care and maintenance. Failure to properly maintain and care for the product may result in voiding this warranty. Prolonged exposure to liquids may damage the laminate flooring; therefore spilled liquids must be wiped up immediately. Cleaning with excess water or the use of inappropriate cleaners will void the warranty. This product must never be waxed, polished nor steam cleaned. Scratches caused by sand or grit will also not be covered. - **8. Second quality and clear-outs.** Only first quality goods are covered by this warranty. Products sold as second quality or as part of a promotion are considered sold "as is" and are not covered by Beaulieu's warranty.



GENERAL

These warranties apply only to the original purchaser and to flooring in its original installation, and are not transferable. Ensure you keep your original receipt as proof of purchase. If a problem appears which is covered by these warranties, the original purchaser must contact the dealer within thirty (30) days of detecting the issue to describe the problem.

Beaulieu reserves the right at any time to modify or discontinue any of its products and will not be liable as a result of any such change. If original product or color is no longer available, Beaulieu may substitute reasonably comparable products.

The consumer and installer are responsible for final inspection and approval prior to permanent installation. Before installing, lay out the flooring, blending the planks from several cartons to determine optimum appearance. Beaulieu is not responsible for labor costs to replace visibly defective product after installation.

No person other than a Beaulieu claims department representative is authorized to accept or refuse a warranty claim. No person is authorized to waive or modify the terms of this warranty. Beaulieu reserves the right to designate a representative to inspect the floor and remove samples for analysis prior to accepting or refusing any claim. No repairs (except for urgent and necessary repairs) may be made until after such inspection or until Beaulieu indicates that such inspection is not required.

If a defect covered by these warranties appears during the warranty period, Beaulieu will, at its discretion, repair or replace the defective product. Labor costs for removal and reinstallation of product are not included.

These limited warranties do not include the cost of moving furniture or other heavy objects. The owner is responsible for providing a clear floor area to allow warranty repair work to be carried out without hindrance. The replacement product is warranted for the remainder of the original warranty period.

If Beaulieu reimburses you for your flooring under the terms of these warranties, Beaulieu will credit a percentage of the original floor purchase price according to the following proration chart.

SOME STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF IMPLIED WARRANTIES OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THAT THE ABOVE EXCLUSIONS OR LIMITATIONS MAY NOT APPLY TO YOU. THIS LIMITED WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY HAVE OTHER LEGAL RIGHTS WHICH VARY FROM STATE TO STATE. PLEASE KEEP YOUR RECEIPT AS BEAULIEU REQUIRES IT IN ORDER TO VERIFY DATE OF PURCHASE.

HOMEOWNER OBLIGATIONS

If by any chance the product underperforms its expectations and to ensure a fast and easy warranty claim, please keep at least four (4) pieces of flooring for testing purposes. Also ensure to keep the original sales receipt. Make sure the flooring was installed according to the Beaulieu Laminate Installation Instructions and maintained according to the Beaulieu Laminate Care and Maintenance guidelines which can be found on line at www.beaulieuflooring.com or by contacting Technical Services at 800-944-2840 or tek.services@beaulieugroup.com. You must also keep a list of products used to clean the floor.

The warranty terms set out above apply to all products sold after April 1st, 2016 and replace all previous warranties.
